### A Sad Goodbye to our Sycamore Tree

I am sad to announce that the beautiful 60 to 65-year-old Sycamore tree that is the centerpiece of our memorial garden had to be removed on July 21st.

This was not an easy decision but one that had to be made. Over the past winter the roots surfaced and have caused such damage to the garden that it is not safe to allow the public inside the gates to enjoy the garden's peace and beauty.

We had three separate professional Arborists evaluate the tree. They all said the same thing, "If there was a way to save the tree they would, but there is not." We were left with the option of either keeping the tree or keeping the garden.

In order to repair the damage, parts of the garden will have to be disassembled, cleaned up, and then reassembled. With the removal of the tree, there will have to be some redesign of the garden. The committee recognizes that in the present time of Covid-19, we will most likely be worshiping in the garden more than just on the Day of Pentecost. With that in mind, the committee is exploring ways to maintain the current essence of the garden while adding some more square footage that will lend itself to meaningful worship space.

The committee members are Sandy and Doug Houston, Dick Stufflebeam, Tim Miller, and me. We will work with professional landscape designers to help us revision the future of our garden.

Gracious Creator, giver of life and all that is good, we thank you for our Sycamore tree. We thank you for its beauty and for the generation of shade it has given the Earth. During a time when losing one more thing seems unbearable, we know you are with us in our loss. ### Food Pantry Vegetable Garden News:



The garden has done well this summer, we have been harvesting squash, cucumbers, strawberries, green beans, tomatoes and herbs for the last three weeks. The Food Pantry clients appreciate the fresh organic vegetables. If you are interested in weeding & tending, I am

usually at the garden on Monday's, Wednesday's and Saturdays at 7:45 am, Please feel free to show up to help - call me, Mary Gonzales 505-730-7722 and let me know if you would like to help, so I know you are coming. Masks are required, but we are outside, and the fresh air is a blessing.

## Funding the Mission July 2020



Although we are four months into the pandemic with suspended in person worship services, our financial results continue to be very positive. Operating receipts for the second quarter totaled \$82,923 and operating expenses totaled \$71,224. This gave us an operating surplus for the quarter of \$11,699 which beat the budget's predicted deficit of \$6,702 by \$18,401.

The larger six-month picture is equally positive. Our total operating surplus for the year stands at \$29,360. The 2020 budget predicted a \$6,625 surplus at this point.

Unlike last quarter where our moderate budget beating numbers were due to lower than expected expenses, this quarter's large surplus was almost entirely due to higher than expected donations. General giving, even in the absence of passing the physical plate at services, exceeded the budget by \$4,500, and pledge donations exceeded the 2nd quarter budget by over \$13,000. On the expense side for the 2nd quarter, we were right on track. Several of our normal expenses were lower due to the building being closed, but those savings were offset by some unbudgeted Covid-19 expenses (e.g. audio-visual equipment for Zoom worship, extra cleaning, etc).

The monthly Financial Statement of Mission contains detail on all our financial activity but is
